

## MEET YOUR 2025 WARDEN CANDIDATES

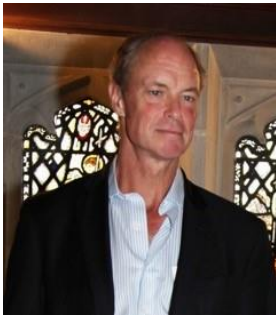


### **STEPHANIE CLARK (Warden Candidate)**

**FAMILY:** Fred (husband), Junius, Anne (children)

Stephanie heads up Campus Recruiting for the Investment Bank at UBS.
